

Study of the uses of group work with parents in permanency planning services; presents a conceptual framework and literature review and an example of group work with parents of children in foster placement.

Describes the Alameda Project and presents data from its first year.

Results from the Alameda Project after two years, with discussion of case planning, the use of written contracts, and issues related to service delivery.

Theodore, J. GAMBRILL, Eileen, D., and WILTSE, Kermit T. -'Foster Care: The Use of Contracts', <u>Public Welfare</u>, Fall, 1974, pp. 20-25.

The purpose of this article is to discuss the use of contracts with natural parents as a tool for encouraging parental participation in planning for their children and early decision-making.

Describes issues related to the approach used in the Alameda Project, where case management was divided between two workers, one responsible for intensive services to natural parents, the other concerned with the child in the foster home.

Theodore J., GAMBRILL, Eileen D., and WILTSE, Kermit T. -Children in Foster Homes: Achieving continuity of care, Praeger, New York, 1978 (362.733).

Studies the continuity of care for children in out-of-home placement; compares with more traditional methods, the effectiveness of a systematic case-management procedure using behavioural intervention methods, with the objective of developing a decision-making framework that can be used

by child care workers, supervisors, administrators and social work educators. Also offers an analysis of the barriers to the introduction of systematic case management procedures that are found in child welfare agencies.

WILTSE,

Kermit T. - 'Decision-making needs in foster care', Children Today, Vol. 5, No. 6, 1976, pp. 2-5, 43.

Studies agency decision-making processes that result in children entering, remaining in, and exiting from foster care, and the tendency for them to drift.

Celia - 'Assessing adolescents for time-limited foster care', <u>Adoption and Fostering</u>, Vol. 6, No. 4, 1982, pp. 26-30.

The issue of how difficult adolescents might be assessed for time-limited family placement, using Attachment theory, describing each adolescent in terms of their existing attachments and compares the 'passively dependent' with the 'fiercely self reliant'.

E. Matilda, and WARBURTON, R. William. - Ends and Means in Social Work, <u>National Institute Social Services Library</u>, No. 35, George Allen and Unwin, London, 1979 (361.942).

Describes the development and outcome of a case review system in a town in southern England.

E. Matilda, WALKER, David, and ROBINSON, James - 'Exploring the task - centered casework method', <u>Social Work Today</u>, Vol. 9, No. 2, 1977, pp. 9-14.

Reports on a small project in an area office of a Buckinghamshire Social Service Department where a group of social workers explored the task-centered casework method 'fairly systematically'.

HUSSELL,

Chris and MONAGHAN, Bernard - 'Child care planning in Lambeth', <u>Adoption and Fostering</u>, Vol. 6, No. 2, 1982 pp 21-25.

Describes how field workers in a London borough translated theory into practice : the objectives of permanent placement and the belief that no child should be in care for more than two years. K MCKAY

Margaret - 'Planning for permanent placement', <u>Adoption</u> and Fostering, Vol. 4, No. 1, 1980 pp. 19-21.

Contributes to the current examination of child care practice based on work in East Lothian and calls for a redefinition of long-term fostering.

TRISELIOTIS Dr John - 'Identity and security in adoption and long-term fostering', <u>Adoption and Fostering</u>, Vol. 7, No. 1, 1983, pp. 22-31.

> Draws from a larger study which contrasted those people who grew up adopted, with those people who grew up in long-term fostering; so as to examine, mainly, issues in identity formation.

TRISELIOTIS John. ed. - <u>New developments in foster care and adoption</u>. Routledge and Kegan Paul, London, 1980 (362.733).

> New developments which are of direct relevance to social workers, e.g. the concepts derived from the special projects set up to find families for hard-to-place children.
